8. I understand that I may be required to provide documented evidence of any interprovincial mare movement in terms of the Rules.

In particular I acknowledge that any decision by Race Cast and / or the KZN Breeders Board is final and binding on any claim made by me in terms of the scheme and furthermore that any false declaration made by me in this affidavit, or any false claim, could at the discretion of Race Coast and / or the KZN Breeders Board, make me ineligible to claim from the scheme now and at any time in the future.
